Update on 2021 Business Personal Property Listings Due on April 15, 2021

As you know, we are in unprecedented times due to the COVID-19 pandemic. Mecklenburg County realizes that companies may experience challenges in meeting the April 15, 2021 deadline.

The Mecklenburg County Board of Equalization and Review has approved the following policy to assist taxpayers in filing their 2021 Business Personal Property Listing. Taxpayers that meet the following requirements will be granted a waiver of the 2021 Late Listing Penalty.

- 1) The taxpayer requested an extension on or before February 1, 2021;
- 2) The taxpayer will file the Listing on or before May 17, 2021; and
- 3) The taxpayer will file a request for waiver.

Below is the 2021 COVID-19 Request for Waiver of the 2021 Late Listing Penalty Form. If you meet the above criteria and need additional time to file the 2021 Business Personal Property Listing due to the COVID-19, please sign and return the enclosed form by May 17th, 2021 via USPS or the email address below.
