**1 HIV, AIDS and Syphilis cases are reported Quarterly.** 212 newly diagnosed HIV disease cases and 85 newly diagnosed AIDS cases were reported in Mecklenburg County during 2020 (based upon the most recent surveillance data). During the same time period, there were 559 newly diagnosed Syphilis cases (primary, secondary and early latent). Readers should note that HIV disease represents all diagnoses of HIV infection regardless of the stage of the disease.

**2 Category A Bioterrorism Agents/Disease** including pathogens that are rarely seen in the United States and that pose a risk to national security because they can be easily disseminated or transmitted from person to person; result in high mortality rates and have the potential for major public health impact; might cause public panic and social disruption; and require special action for public health preparedness.
