If you answered “**Yes**” to any of the above questions, **you must complete and submit a “NESHAP Notification of Demolition and/or Renovation” form for each building/structure with an address** and receive approval from MCAQ before demolition permits will be issued by the Code Enforcement Division.

If you answered “**No**” to all of the questions, the asbestos NESHAP does not apply to your project.

This questionnaire is an aid in determining regulatory applicability in most situations, but does not cover every scenario. If you have an unusual situation that you are not sure was addressed in this questionnaire, or if project circumstances change after completion of the questionnaire that alter the answers to any of the above questions, please contact MCAQ for compliance assistance.
